## **ELECTION PROCEDURE**

According to the Association's statutes, Board members are elected by the members present or represented by proxy at the Annual General Meeting.

<u>Corporate Members only</u> have the right to vote in the election of all candidates (no geographical restrictions). Where for a particular country, there is more than one candidate for election, the candidate securing the highest number of votes shall be elected.

<u>Voting by Proxy:</u> Corporate Members, who will not attend the AGM, may ask another Corporate Member present at the meeting to vote on their behalf. If you wish another member to vote on your behalf, you must complete the Proxy Form and return it to the TII Secretariat by email, no later than <u>**Tuesday 24 May**</u>. The Association's Statutes specify (Article 16) that a voting member may exercise no more than **two proxies**.

Please do not nominate the Secretary General to exercise a proxy vote on your behalf. Not being a member of the Association, she is not empowered to vote.

#### PROFESSIONAL EXPERIENCE AND QUALIFICATIONS

## PROFESSIONAL EXPERIENCE AND QUALIFICATIONS

Salvador Pastor has a BSc in Electronics from the Universidad Politecnica de Valencia and the University of Nottingham as well as an MSc in Business Management and Engineering from the Universidad Politecnica de Catalunya. After an early career as a technical supervisor with a manufacturer of steam/oil boilers, a sales and marketing executive, quality manager and researcher, he then spent the next 7 years managing the logistics activities of companies in a range of sectors – automotive, home textiles and travel equipment. In 2005 he set up his own consulting company and worked with a number of different clients, including the Business and Innovation Centre of Alcoy from 2005 to 2010.

## **STATEMENT**

"In the following lines I will describe succinctly my personal insights on the future vision of TII as the leading European Association for the transfer of technology and the promotion of innovation, and will describe the basic topics in which my modest participation in the Board of Management can contribute to reach the Association's operational objective of "*promoting exchanges of information and cooperation between any bodies involved in the transfer of industrial information and exercising activities*", as indicated in TII's rules and statutes.

## 1 Technology as a wide concept

The concept of technology transfer has been inevitably associated in the last decades with the relationship between Scientific Communities (generally Universities and Technological Institutes) and Companies. The transition from an Industrial Economy towards a Knowledge Economy has led to substantial changes in the way Information and Knowledge in general, and Technology in particular, flows from its "sources" to its "destinations".

In fact, the sources of technological progress have become diverse and do not belong anymore only to the Scientific Communities. More informal or spontaneous Social Groups have gained their right to contribute to the process in transferring Technology (these being overtly understood as the applicability of knowledge in real-life solutions) to companies and individuals.

#### 2 Open innovation attitude

Even though the concept of "Open Innovation" and its extension to more refined notions like "Embedded Innovation" or "User-driven innovation" have a large presence in research papers and scientific congresses, it is a fact that it has not yet rooted in SMEs as a means to leverage their growth and to create new jobs and business opportunities. Indeed, there is a gap (both in the discourse and in practice) between what is being said in academic forums and in corporate environments. TII can count with my modest contribution to close that gap and help companies adopt simple and straightforward Open Innovation methodologies inside their organisations.

#### **3** Approaching Private firms

For many years, Technology Transfer issues have been associated with public or semi-public bodies, often depending on their supervisory administration structures in terms of prioritizing actions and initiatives. Even though TII's composition is particularly well balanced and diverse, introducing even more participation of private and independent bodies is certainly a way to improve and enrich the points of view and the interests existing in the Association. Furthermore, this more intense collaboration can lead in the future to public-private partnerships between TII members to deliver joint Technology Transfer projects.

#### 4 Use of emerging collaboration tools to raise productivity

The eruption of Internet-based networking and collaboration tools has given new opportunities for networking in Associations such as TII and, at the same time, has generated a true challenge, and a new competitor for the exchange of information with their members. Far from seeing these phenomena as a threat to TII's activities, these tools can truly contribute both to expand TII's communication skills, and to increase efficiency and productivity in the internal processes. This, in turn, can give TII the chance to dedicate more time to rethink and redesign its role among its members in the new Knowledge and Information era, in which information is becoming less and less valuable, and knowledge is becoming more and more accessible to all layers of society. As the analysis and implementation of these tools is one of my professional activities inside organizations, I will be pleased to give support to TII in this field, both internally, and in dissemination/training activities for its members
